ORDINANCE NO. 120

AN ORDINANCE OF THE CITY OF DOVER, BONNER COUNTY, IDAHO, AMENDING ORDINANCE NO. 102 BY REPEALING "SECTION 2 - REGULATING THE USE OF CITY HALL and CITY PROPERTIES" IN ITS ENTIRETY AND SUBSTITUTING "SECTION 2 - REGULATING THE USE OF CITY PROPERTIES"; ESTABLISHING FEES BE SET BY COUNCIL RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council has determined that a change was needed in Ordinance No. 102 Section 2, regarding the usage of City Hall.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Dover, Idaho as follows:

SECTION 1. Change Section 2 of Ord. No. 102. The following paragraph repeals the original Section 2.of Ordinance 102 in its entirety:

"SECTION 2. Regulating the Use of City Properties.

- a. No person(s) or group(s) shall use the City Hall for private use, without prior approval for the usage by the Mayor or two (2) City Councilmembers. A City employee and/or City Councilmember must be present during the time period approved for that use.
- b. City Hall may be rented for public use by an individual, organization(s) or group(s) by first submitting an application for Facility Use and Rental Agreement to the City Clerk, and obtaining approval by the Mayor.
- c. The amount of the Facility Use Fees or Rental Fees for the use of City Hall and/or Council Chambers may from time to time be adjusted by Resolution of the City Council without amending this Ordinance or Ordinance No. 102.
- d. If an event or proposed usage is sponsored by the City of Dover such event or proposed usage shall be exempt from any rental fees for the use of City Hall or City properties including Park Areas.
- e. The City shall have priority usage of the City Hall over any and all Facility Use Rental Agreements, as stated in the Facility Use Agreement. If for any reason a reservation for use is cancelled by the City, all funds for that reservation will be refunded."

SECTION 2. <u>Effective Date.</u> This Ordinance shall be in full force and effect upon passage and publication as provided by law.
