

**ORDINANCE NO. 137
CITY OF DOVER, IDAHO**

AN ORDINANCE OF THE CITY OF DOVER, A MUNICIPAL CORPORATION OF THE STATE OF IDAHO, SETTING FORTH THE REGULAR MEETING DATES, PLACE AND TIME OF THE DOVER CITY COUNCIL; DESIGNATING THE OFFICIAL NEWSPAPER OF THE CITY; AND REPEALING ORDINANCES NO. 2, 20, 25, 35, 36, 45, 48, 60, 77, 90, and 132.

BE IT ORDAINED by the Mayor and Council of the City of Dover, Idaho:

SECTION 1. REGULAR MEETING DATE

The regular meeting of the City Council shall be held on the second and fourth Thursday of each and every month, except if said Thursday is a holiday, in which case only one meeting will be held for that month.

SECTION 2. REGULAR MEETING TIME

The regular meeting time shall be six o'clock (6:00) p.m. and all regular meetings shall be open to the public, except executive sessions, as provided in Idaho Code 67- 2345.

SECTION 3. REGULAR MEETING PLACE

The regular meeting place shall be Dover City Hall, 699 Lakeshore Ave., Dover, Idaho.

SECTION 4. PUBLICATION

The Bonner County Daily Bee is hereby established as the official newspaper of the City.

SECTION 5. SEVERABILITY

The sections of this ordinance are severable. Should any sections of this ordinance be declared invalid by a court of competent jurisdiction, such declaration shall not affect the validity of the remaining sections.

SECTION 6. REPEAL

Ordinance No. 2, enacted August 9, 1988; Ordinance No. 20, enacted November 10, 1992; Ordinance 25, enacted October 7, 1993; Ordinance No. 35, enacted April 4, 1996; Ordinance 36, enacted April 25, 1996; Ordinance No. 45, enacted June 6, 1998; Ordinance No. 48, enacted April 8, 1999; Ordinance 60, enacted September 4, 2001; Ordinance 77, enacted May 19, 2005; Ordinance No. 90, enacted July 18, 2006; and Ordinance 132, enacted April 24, 2014 are hereby repealed.

SECTION 7. EFFECTIVE DATE


This ordinance shall effective upon passage and publication in one (1) issue of the Bonner County Daily Bee newspaper, as provided by law.

Enacted as an ordinance of the City of Dover, Idaho, on the 22nd day of January, 2015 upon the following roll call vote.


