

ORDINANCE # 4

AN ORDINANCE OF THE CITY OF DOVER, BONNER COUNTY, IDAHO, ENTITLED "THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1988", APPROPRIATING \$183,200.00 TO DEFRAY THE PROPERTY EXPENSES AND LIABILITIES OF THE CITY OF DOVER, IDAHO, FOR SAID YEAR PURSUANT TO THE PROVISIONS OF SECTION 50-1003 IDAHO CODE, LEVYING A SUFFICIENT TAX UPON THE TAXABLE PROPERTY WITHIN SAID CITY FOR GENERAL REVENUE PURPOSES FOR WHICH SUCH APPROPRIATION IS MADE, PROVIDING FOR A COPY OF THIS ORDINANCE TO BE FILED WITH THE BONNER COUNTY COMMISSIONERS, AND PROVIDING FOR THE PUBLICATION OF THIS ORDINANCE. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DOVER, BONNER COUNTY, IDAHO:

SECTION 1: THAT THE SUM OF \$183,200.00 BE AND IS HEREBY APPROPRIATED TO DEFRAY THE NECESSARY AND PROPER EXPENSES AND LIABILITIES OF THE CITY OF DOVER, BONNER COUNTY, IDAHO, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1988.

SECTION 2: THAT THE OBJECTS AND PURPOSES FOR WHICH SUCH APPROPRIATIONS ARE MADE ARE AS FOLLOWS:


FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1988, AS SET FORTH
HEREIN, THE DOVER CITY COUNCIL HAS DETERMINED AND HEREBY
CERTIFIES TO THE BONNER COUNTY COMMISSIONERS THAT THE TOTAL
AMOUNT OF MONIES REQUIRED AND NECESSARY TO BE RAISED FROM TAXES
ON ALL PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY OF DOVER,
FOR ALL PURPOSES FOR THE FISCAL YEAR OCTOBER 1, 1988, TO
SEPTEMBER 30, 1989, IS IN THE AMOUNT OF \$20,000.00.

SECTION 4: THE PROVISIONS OF THIS ORDINANCE ARE HEREBY
DECLARED TO BE SEVERABLE AND IF ANY PROVISION OF THIS ORDINANCE
OR THE APPLICATION OF SUCH PROVISION TO ANY PERSON OR CIRCUM-
STANCE IS DECLARED INVALID FOR ANY REASON, SUCH DECLARATION SHALL
NOT AFFECT THE VALIDITY OF THE REMAINING PORTIONS OF THIS
ORDINANCE.

SECTION 5: THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FULL
FORCE UPON ITS PASSAGE, APPROVAL AND PUBLICATION IN ONE (1) ISSUE
OF THE SANDPOINT DAILY BEE, A NEWSPAPER OF GENERAL CIRCULATION
PUBLISHED WITHIN THE CITY OF SANDPOINT AND THE OFFICIAL NEWSPAPER
OF THE CITY OF DOVER. PASSED AND ADOPTED AS AN ORDINANCE OF THE
CITY OF DOVER, IDAHO AT A REGULAR SESSION OF THE CITY COUNCIL OF
THE CITY OF DOVER ON SEPTEMBER 13, 1988.
