

ORDINANCE #3

AN ORDINANCE TO AMEND ORDINANCE #1 OF THE CITY OF DOVER, IDAHO, TO INCLUDE AND ADD TO THE CORPORATE LIMITS OF THE CITY OF DOVER, IDAHO, CERTAIN TERRITORY CONTIGUOUS AND ADJOINING THERETO LYING NORTH AND EASTERLY OF THE CITY OF DOVER, IDAHO.

PROVIDING THE LEGAL DESCRIPTION THEREOF.

PROVIDING FOR THE PUBLICATION OF THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF DOVER, IDAHO:

SECTION 1: Ordinance #1 of the City of Dover, Idaho, be amended to change the real property description to read as herein contained. Under and by virtue of the laws of the State of Idaho, and the Mayor and Council hereof having deemed the following described territory as contiguous and adjacent to the corporate limits of this City and necessary for the orderly development thereof, the following territory is hereby annexed, added to and included within the corporate limits of the City of Dover, Idaho, to-wit:


Commencing at the East Quarter corner of Section 29, Township 57 North, Range 2 West, Boise Meridian; Thence West 1590' to the True Point of Beginning; Thence South 1715'± to the South boundary of Highway #2; Thence Southwesterly 400'± to the Northwest corner of Lot 3 of Dover tracts; Thence South along the West boundary of Lot 3 and 4 of Dover tracts and beyond a distance of 420'± to the shore of Pend Oreille River; Thence East along the shore of Pend Oreille River to the East boundary of Section 29, Township 57 North, Range 2 West, Boise Meridian; Thence Easterly 200'± to the West shore of Chuck Slough; Thence Northerly along the West shore of Chuck Slough to Ontario Street to at a point of 1980'± East of the West line of Section 28, Township 57 North, Range 2 West, Boise Meridian; Thence Northerly along the West shore of Chuck Slough 660'; Thence West to the West line of Section 21, Township 57 North, Range 2 West, Boise Meridian; Thence Southerly along said Section line to the Southeast corner of the Northeast Quarter of the Northeast Quarter of Section 29, Township 57 North, Range 2 West, Boise Meridian; Thence West to the West boundary line of Section 29, Township 57 North, Range 2 West, Boise Meridian; Thence South to the Southwest corner of the Northwest Quarter of said Section 29, Township 57 North, Range 2 West, Boise Meridian; Thence East 3690'± to the Point of Beginning.

SECTION 2: This Ordinance shall be in full force and effect from and after its publication, as provided by law, in the Sandpoint Daily Bee.

THIS ORDINANCE PASSED under suspension of the rules and duly enacted as an Ordinance of the City of Dover, Idaho, at a Regular Meeting of the Council on the 13 day of September, 1988.


