A RESOLUTION TO ACCEPT FOR PUBLIC MAINTENANCE CERTAIN RIGHTS OF WAY LOCATED WITHIN THE PLAT OF CEDAR RIDGE ADDITION, BOOK 5 OF PLATS, PAGE 177 RECORDED AT 510560 BONNER COUNTY RECORDS.

WHEREAS, the plat for Cedar Ridge Addition Book 5 of Plats, Page 177, records of Bonner County, Idaho ("Plat") identifies certain rights of way within the Plat as dedicated to the public but privately maintained;

WHEREAS, the City of Dover ("City") and the Cedar Ridge Homeowners Company entered into an agreement for the City to accept public maintenance of certain rights of way within Cedar Ridge Addition; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF DOVER, IDAHO AND THE INDEPENDENT HIGHWAY DISTRICT:

The City accepts the following public rights of way to be publicly maintained: Essex Road, Cedar Ridge Road and the 20' strip along the west side of Syringa Heights Road, as these rights of way are described and laid out on the Plat. Effective the last date executed by the parties below.
