#### **CALL TO ORDER**

Mayor Curless called the December 8, 2011 City Council Meeting to order at 7:05 p.m.

#### **Public Comments:**

ENGINEER: The Sanitary Restriction Lift Letter will be submitted to DEQ this month per Rob Tate. It was requested that the Mayor contact S. Weeks, Atty. re: New Water Intake System

PLANNER: The Grant Application for buoys and sand for City Beach will be submitted this month. Corrected drawing was submitted to Bonner County Waterways for the buoy project showing 3 extra buoys. 2 sections not present in the City's current Comp Plan need to be addressed according to State Code. P&Z Commission will be working on Section 12 – Signs, of the Zoning Ordinance. Council and P&Z need to schedule a joint meeting in the near future re: future projects, etc. The City Road Standards need to be separated out from the current Zoning Ord. Steve Gill, DEQ and the Brownsfield Project will need to be rescheduled for January Meeting.

TRANSPORTATION: New routes and new stops will be incorporated into the SPOT line by January, to include a run to Schweitzer and to "fine-tune" the existing routes for better ridership.
