**ORDINANCE #102 PARKS**

**Section 1G:** change to: means any Americans with Disability Act (ADA) approved animal that is individually trained to do work or perform tasks for a person with disabilities.

**Section 1a:** Delete

**Section 1h:** Change last part to aid a person “with disabilities.

**Section 1k Loitering:** Delete. Add to Nuisance Ordinance (work in process)

Discussion on Section 2 regarding renting City Hall. Consider renting to:

1. Governmental agencies
2. Organizations, businesses
3. No alcohol
4. During open hours or with permission
5. Councilwoman Burge has problem with private event that excludes the public
6. Councilman Darling has a concern with documents that could be lost due to carelessness (fire).

Council will contact Mr. Snedden to see if the City can define potential rental groups. Councilwoman Shaha will contact Jim McNall for advice on how to limit City Hall users as well as contact other cities.

**Section 2:** Delete

**Section 3a:** Change hours of operation to shall be closed to the public every day of the year half hour after sunset and half hour before sunrise.

**Section 3b:** Delete “the City Hall” just before parking lot.

**Section 3c:** Delete

**Section 4b:** change last part to as per ADA guidelines.

**Section 4c:** Delete

**Section 8a:** Change to No person(s) shall use, shoot, fire or cause to use, shoot or fire any weapons...

**Section 9b:** Delete “on the City Notice Board. Delete sentence, “No other exterior, directional or advertising signs shall be permitted”. Ask Mr. Snedden if last line is needed.

**Section 10:** Include Section 3D from Ordinance #123

**Section 11:** Delete

**Section 12:** Delete last section “without prior written permission from the City and in a designated area.

Will start next Ordinance meeting with Section 13.

Following Ordinance discussion was an update from the Mayor on the City Clerk position. A new ad will be written and posted for the position.

Councilwoman Shaha will do a quarterly budget review for the next City Council meeting.
